What is it like at a Child Contact Centre?

There is a wide range of games, toys and books for children and young people of all ages.

We employ an experienced coordinator and she is supported by a fully trained and vetted team of volunteers.

Impartiality is essential to the work of the centre and there is a strict code of confidentiality. There is a comprehensive list of policies and procedures which are available to you and the protection and welfare of your child is at the centre of our service.

How do we arrange to come?

Solicitors, social workers, the court or parents themselves can contact the coordinator regarding vacancies – the coordinator will make contact with both parents and discuss arrangements for a pre-visit to the centre. The coordinator will discuss available information with both parents and ensure that the centre is a suitable venue for the contact.

Does the centre make any reports about us?

We are independent of the courts, social services or other statutory agencies. We do not make verbal or written reports other than the dates and times of attendance. The only exception to this is if we believe that a child is at risk, or if a member of staff, volunteer or centre user is at risk of harm.

May I take my child out or bring someone else with me?

Only if this has been arranged beforehand by both solicitors and the coordinator has been informed.

Do I have to pay?

There is no charge for using the centre – but we welcome donations. Tea, coffee and other refreshments are available during each session.

Are there any rules?

You will be expected to adhere to the arrangements agreed on the referral form and respect the other clients who will be attending each session.

You will be expected to supervise the welfare of your child during the contact session and be punctual – should you arrive for contact under the influence of drink or drugs you will not be admitted.
